2. Ross, and his agents, successors and assigns and all other persons in active concert or participation with Ross are permanently enjoined from:

a. Making, using, importing, selling or offering to sell the Slide Lock Folding Knife and the Ultra Slim Folding Knife shown in Exhibits 1 and 2 hereto;


b. Making, using, importing, selling or offering to sell any knives or other articles that infringe U.S. Patent Nos. 5,737,841; 6,122,829; 6,574,869; 6,550,832; 6,675,484; and any other knives or other articles covered by patents owned by Mentor or Benchmade Knife Company, Inc.;

3. Prior to selling any knives or hand tools, Ross will search the records of the U.S. Patent and Trademark Office @ <http://portal.uspto.gov/external/portal> to determine whether Mentor or Benchmade Knife Company, Inc. owns patents that cover such knives or other hand tools. Should Ross thereafter sell knives or other hand tools which are covered by patents available to be searched at the time of sale, Ross shall pay Mentor's attorneys fees associated with enforcing such patents against Ross, his agents, successors and assigns.


4. The Court retains jurisdiction of this matter and the parties for the purpose of enforcing this Judgment and the Settlement Agreement and Release between the parties.


