

ORDER ON JOINT STIPULATION OF DISMISSAL

On January 27, 2017, Plaintiff North Star Innovations, Inc. ("Plaintiff" or "North Star") and Defendants Canon U.S.A., Inc., Canon Information Technology Services, Inc., and Canon Virginia, Inc. (collectively, "Defendants" or "Canon") (Plaintiff and Defendants may be referred to collectively as the "Parties"), through their respective attorneys of record, and pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), filed a Joint Stipulation of Dismissal ("Stipulation"). Having considered the Stipulation, and finding that good cause exists, the Court hereby **ORDERS** as follows:

Plaintiff's claims for relief that were asserted or that could have been asserted against DefendantS in this case are hereby dismissed *with prejudice*. Defendants' claims, defenses or counterclaims for relief that were asserted or that could have been asserted against Plaintiff in this case are hereby dismissed *without prejudice*. All attorneys' fees, costs of court, and expenses shall be borne by the party incurring same.
